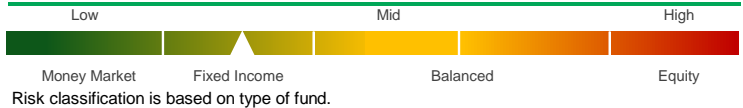

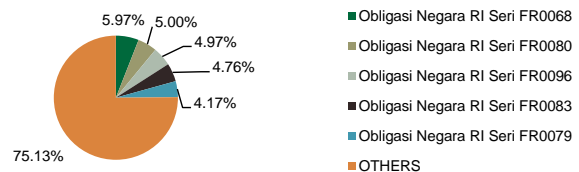
### Risk Classification
