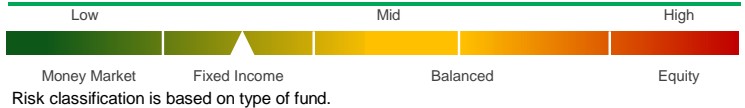

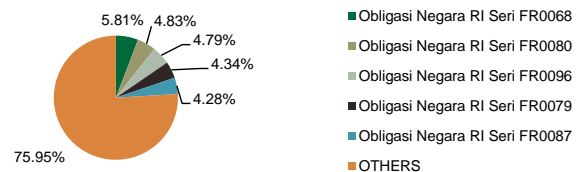
Risk Classification
