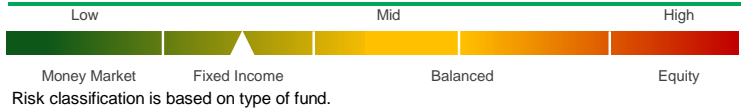

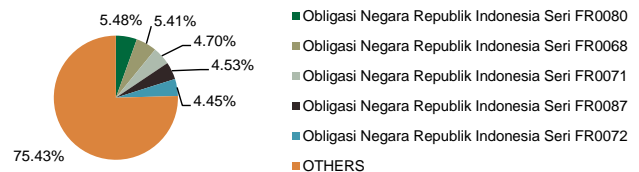
Risk Classification
