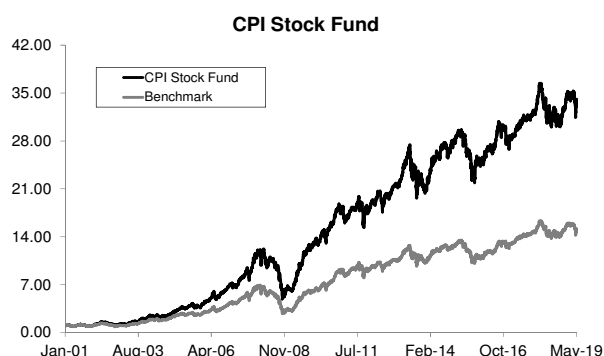

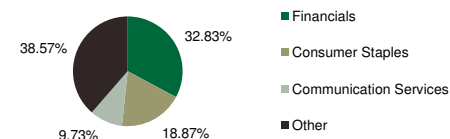
Investment Package Graph
