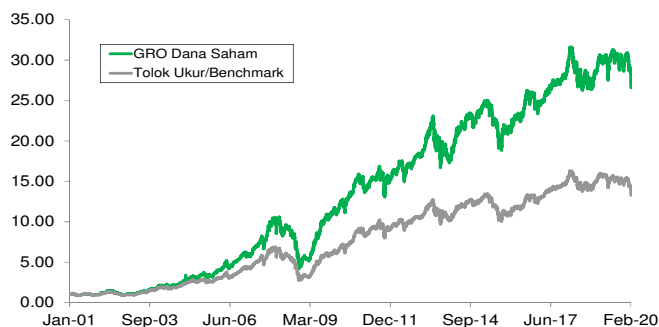

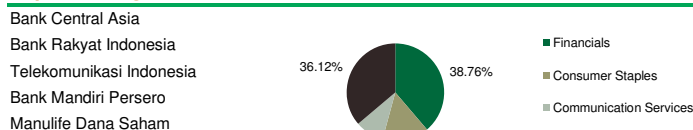
Risk Classification
