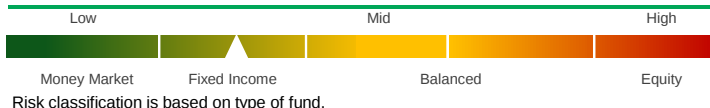

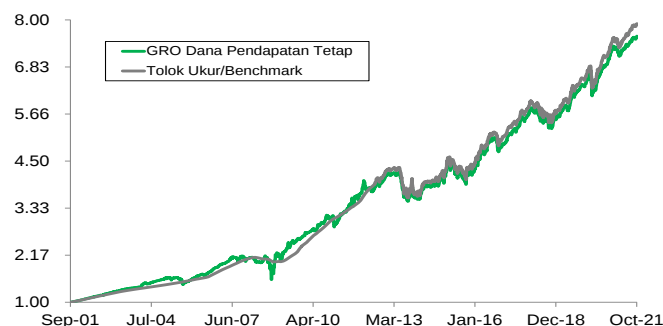

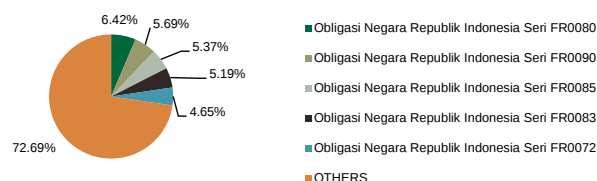
Risk Classification
