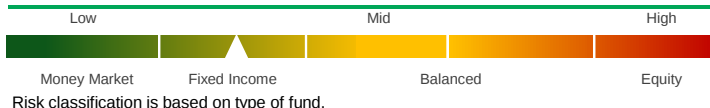

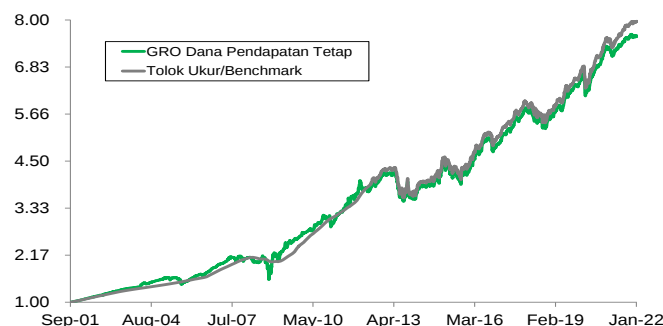

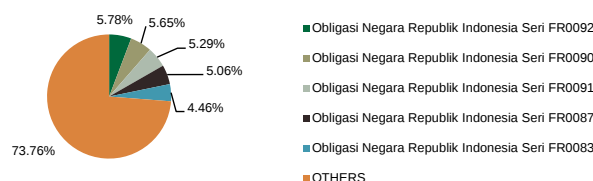
Risk Classification
