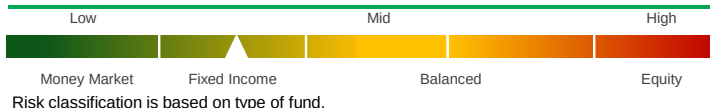

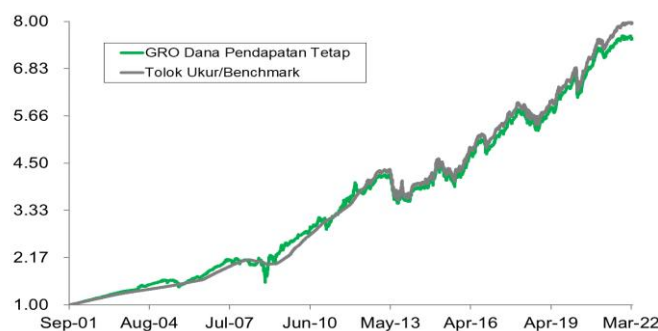

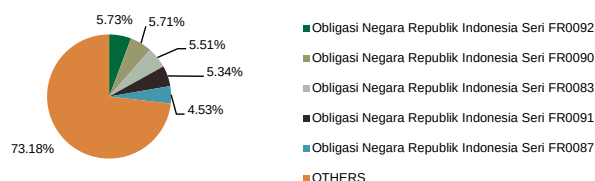
Risk Classification
