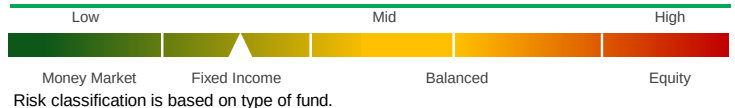

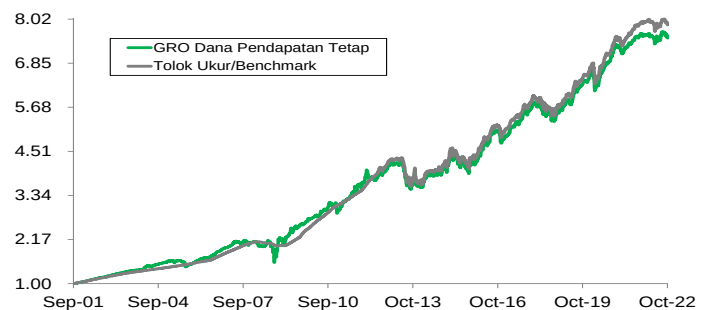

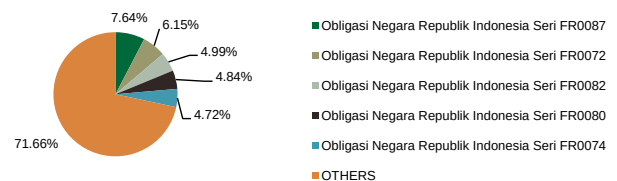
Risk Classification
