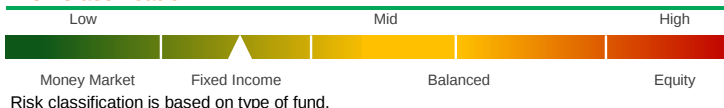

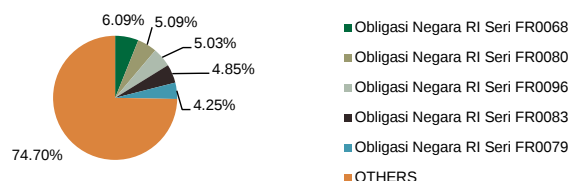
Risk Classification
