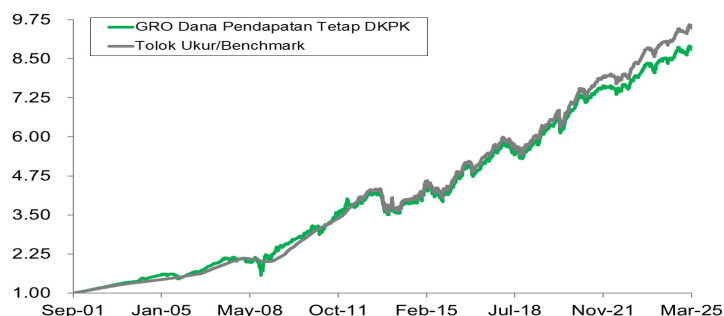

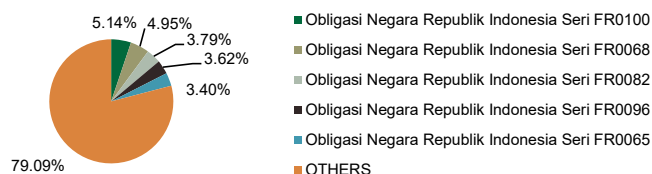
Risk Classification
