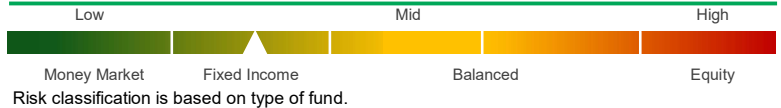

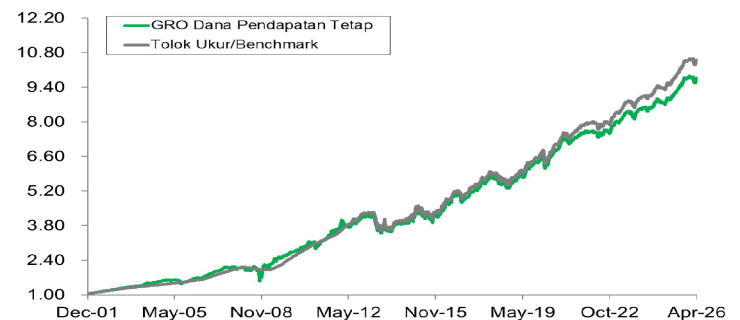

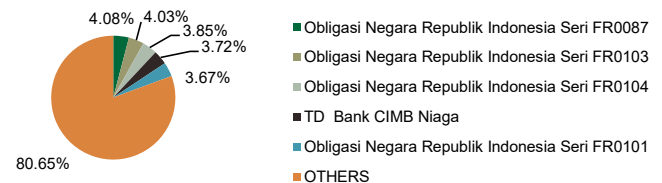
### Risk Classification
