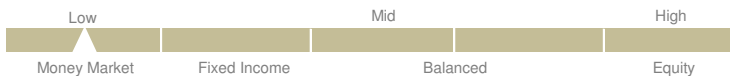

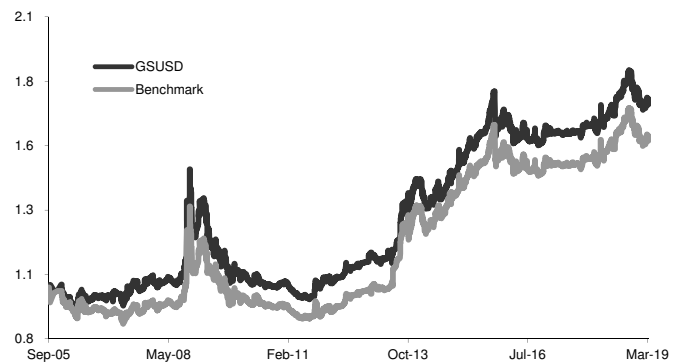

### Risk Classification

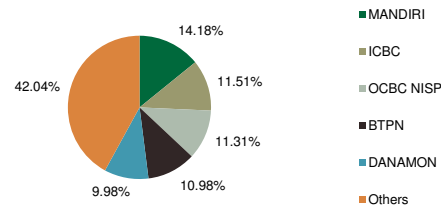


Risk classification is based on type of fund.
