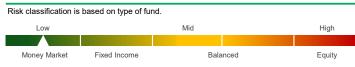

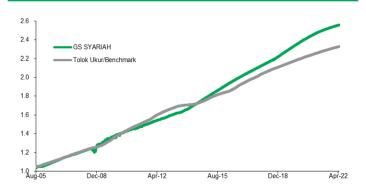

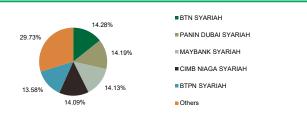
Risk Classification
