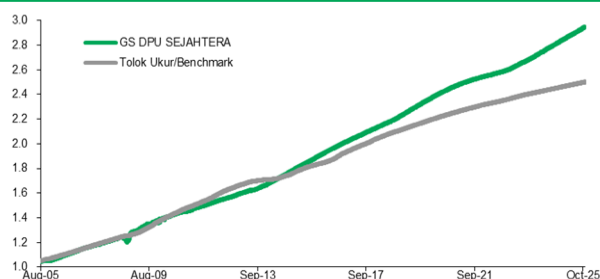

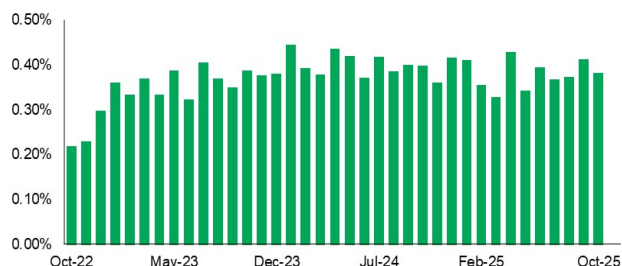

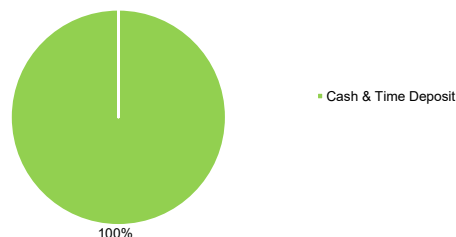


Monthly Performance Last 3 Years
