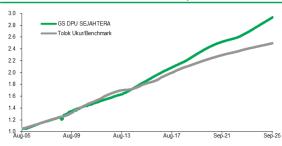

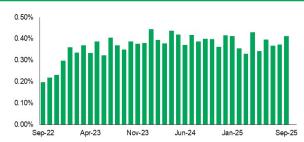

## **Performance Since Inception**



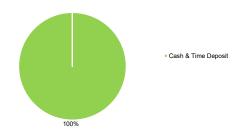
# **Monthly Performance Last 3 Years**
