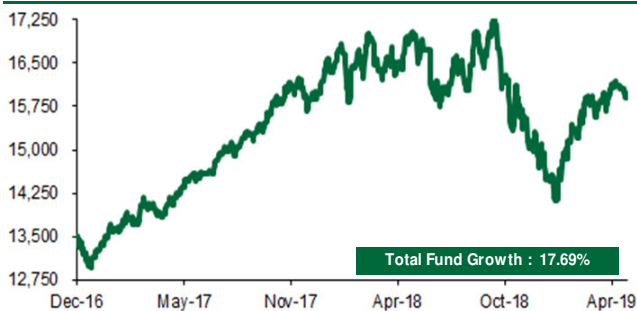

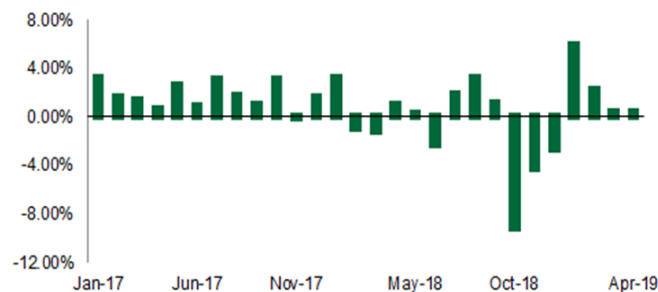

### Performance Since Inception

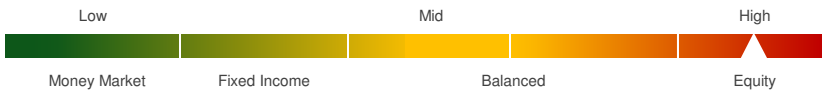


### Monthly Performance Last 3 Years

### Investment Manager Commentary

Throughout April Asia Pacific equity market strengthened driven by better than expected China data, whereas economic growth in first quarter grew by 6.4% YoY while March manufacturing and service sector also showed improvement. China good economic data reduces market concerns about the global economic slowdown. Bank of Japan maintain accommodative stance on monetary policy until at least 2020 because inflation target has not been reached. Bank of Japan policy posture continues the theme of other global central banks that maintain more accommodative stance. FTSE Sharia Asia Pacific ex. Japan in IDR denomination weakened by 0.14%. Higher portfolio performance compared to benchmark driven by positive attribution from industrials, information technology & consumer staples.
