




Performance Since Inception

Investment Manager Commentary

Indonesia economy macro remained conducive in June. Inflation came in subtly with CPI rising +0.55% MoM (+3.28% YoY). The figure is low compared to average June MoM inflation in the past 9 years (2010-2018) of +0.66%. Core inflation was up to +3.25% vs. +3.12% in May as gold price was up +6.1% MoM to USD1,361/ounce. Going forward, the CPI is expected to be manageable as electricity tariff increase is expected to take place in 2020 instead of this year. Bank Indonesia's 7 Day Reverse Repo interest rate remains 6% in June. Portfolio performance was higher than the benchmark due to return from sharia money market placement still quite high.
