

Performance Since Inception

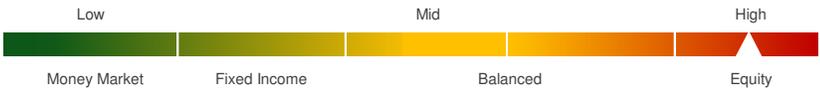


Monthly Performance Last 3 Years



Investment Manager Commentary

Global equity market did not perform well in May, pressured by higher trade tension between US and China. President Trump showed intention to increase tariffs for goods imported from China if no trade deal is reached soon. To mitigate trade war impact to the economy, US central bank showed a more accommodative stance, prepared to support the economy through its policies. On the domestic side, Indonesia economic fundamentals remain solid, as S&P rating agency raised Indonesia's sovereign rating from BBB- to BBB, supported by strong policy dynamics, low debt level, and manageable fiscal condition. IHSG fell 3.81% in May and China equity market in IDR fell 10.42%. Rupiah was relatively stable, only depreciated 0.08% to IDR14,268 per USD. Amid global volatility foreign investors posted net outflow of IDR7.3 trillion in the equity market and IDR10.2 trillion in the bond market. Portfolio allocation in Consumer Discretionary and Health Care sectors result in positive attribution to portfolio, while allocation in Financials and Communications sectors posted negative attribution.
