

#### **Investment Manager Commentary**

Indonesia economy macro remained conducive in May. The CPI was up +0.68% MoM, showing an inflation acceleration to +3.32% YoY from 2.83% YoY in the previous month. Main trigger is foodstuff inflation of +0.43ppt, contributing 63% of total inflation, as prices of chili, onion, and chicken meat went up in light of the Ramadhan and the Eid. Year-to-date, 5M19 inflation came in at 1.48%, compared to 1.30% in 5M18. Core inflation increased to 3.12% in May from 3.05% in April. Bank Indonesia's 7 Day Reverse Repo interest rate remains 6% in May. Portfolio performance was higher than the benchmark due to return from money market placement still quite high.
