




Performance Since Inception

Investment Manager Commentary

Indonesia macro economy continued to show a mixed picture in June, still subdued in consumption related activities but sustained stability and demonstrated improved risk perceptions. Inflation came in at 0.18% MoM, in June 2020, still low but increased from 0.07% MoM in May. On an annual basis, the CPI stood at +1.96% YoY, down from +2.19% in the previous month. Core inflation registered at +2.26% YoY. The low core inflation reflected weak demand triggered by the Covid-19 pandemic. Administered prices posted a +0.22% MoM inflation as the government began relaxing operating restrictions on public transportation in early June 2020. Bank Indonesia lowered 7 Day Reverse Repo to 4.25% in June. Portfolio allocation in short term bonds posted lower return in June.
