



Investment Manager Commentary

The equity market posted positive performance in May, where MSCI World index closed higher 2.04%. Market sentiment improved as new Covid-19 cases decreased globally and various countries are planning to loosen lockdown and begin to open the economy gradually. This marks the initial phase of economic recovery, especially as US nonfarm payroll showed 2.5 million people regain jobs, and unemployment rate drop to 13.3% from 14.7% the previous month. The market also welcomed plans for additional stimulus from Europe and Japan to support the economy. Meanwhile the market was concerned by escalating tension between US and China, which may become further risk as we are nearing US election period at the end of the year.
