#### **Investment Manager Commentary**

China equity market was volatile in August. In the beginning of the month, uncertainty about regulatory change in China overshadowed the market. Rising COVID-19 cases in China also triggered strong reaction from the government that place tighter social restriction. As result China economic data fell in August, where services PMI fell to 47.5 in August, the lowest level since February 2020, indicating contraction in economic activity due to tighter restriction. However, market sentiment improves at the end of August as the market viewed that intensity of China regulatory change has peaked, and market valuation has dropped back to attractive level. China regulatory changes are seen as a shift in focus from quantity of growth to quality of growth. We view this as positive to create a more sustainable long term growth for China and will be beneficial for China equity market as well, especially on the new economy industries that benefit from China's structural growth story.
