### Investment Manager Commentary

Asia equity market consolidated in December after a stellar performance +15.6% in November. The Fed raised benchmark rate by 50bps to 4.50 inline with market expectation, a smaller hike compared to 75bps increment the previous months. However, statement from Fed Chair Jerome Powell emphasized that monetary tightening will not be eased in the short term and interest rate may be higher than previous expectation due to persistent inflation and strong labor sector. In Asia, market sentiment is supported by further relaxation of China Covid restriction that boost expectation of economic recovery in China and Asia. On the flip side, there are concerns of rising Covid case in China and the risk of contagion to other countries that could affect mobility and growth outlook. Portfolio allocation in industrials and consumer staples contributed positive attribution, meanwhile allocation in materials and IT contributed negative attribution to performance.
