


Performance Since Inception

Investment Manager Commentary

Uncertainty caused by the Russian Ukraine conflict that coincided with the start of the Fed's monetary tightening cycle weighed on the INDON market in February. INDON's yield rose sharply in line with increased volatility and a sell-off in the risky asset class. The market pays attention to world commodity prices and economic growth prospects. Given that Russia and Ukraine have important roles in the world's oil and gas, metal industry and supply chains, the immediate impact will be rising prices and inflation. Indonesia's direct impact from the Russia Ukraine conflict will likely to be limited due to low exposure in trade (0.8% of total Indonesia exports and 1.1% of imports) and investment (0.08% of FDI). Indirect impact from higher inflation will be more relevant. Yields on short tenor bonds rose more than medium tenors.
