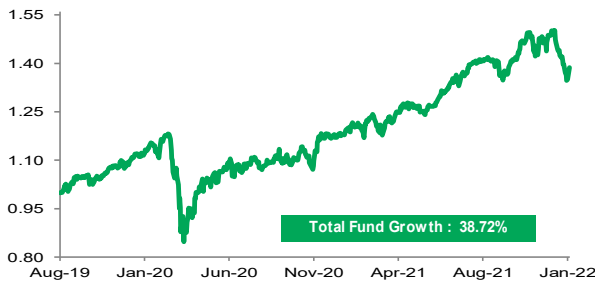

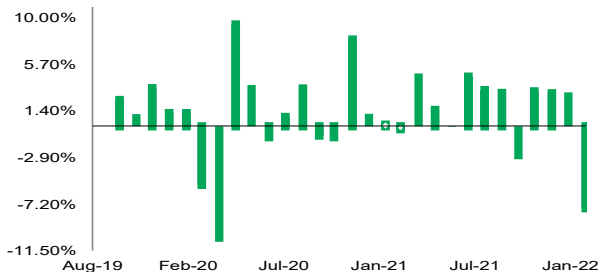

### Performance Since Inception

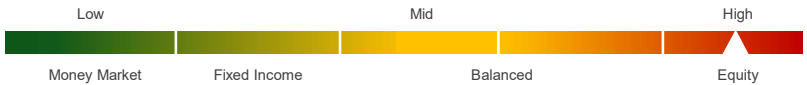


### Monthly Performance Last 3 Years

### Investment Manager Commentary

Global equity market was volatile in January, mainly affected by sentiment regarding US monetary policy. Uncertainty on The Fed's policy weighs on the market following The Fed's hawkish statement in early January that opens the possibility of rate hike in Q1-2022. The Fed also signals the possibility of unwinding its balance sheet (quantitative tightening). This policy uncertainty result in higher market volatility especially on growth stock such as technology sector.
