

#### **Investment Manager Commentary**

Global technology equity posted positive performance in March following volatile condition the previous months. The Fed raised benchmark rate by 25bps in March and signals aggressive rate hike outlook in 2022. The Fed also commented that quantitative tightenting could begin soon. The Fed's hawkish outlook was already anticipated by the market, and it reduced market uncertainty by providing clearer picture of The Fed's path going forward. Global technology equity rebounded following the FOMC meeting, positive performance in March. However, market volatility remains relatively high, as Russia - Ukraine conflict caused rising commodity prices and adds inflation pressure to global economy. Amid volatile market condition, the portfolio emphasize on investment in long-term secular growth trends such as artificial intelligence, semiconductor, digital transformation, electric vehicle, and fintech offer attractive investment prospects.
