


## **Performance Since Inception**

# **Investment Manager Commentary**

Global stock market weakened over concerns that the Fed's aggressive rate hikes could push the economy into recession. Market sentiment was further depressed after earnings reports from retail companies indicated pressure from rising energy prices, and supply chain disruptions affecting profitability. To combat inflation, the Fed raised interest rates by 50 basis points to 0.75-1.00% from 0.25-0.50% previously. The minutes of the FOMC meeting indicate the flexibility of the Fed's policy direction. Fed officials indicated a 50bps hike was needed in the next two meetings to provide flexibility on policy direction should conditions change. This comment was interpreted by the market as a more dovish tone than the previous statement.
