

Indonesia stock market was outperformed the global and Asia market. Indonesia strong fundamentals, near-peak Fed Funds Rate and disappointing China recovery post economy reopening could support appetite of foreign investors to Indonesia. The domestic bond market experienced a volatile movement on the back of rising 10Y UST yields to 4.35%. Indonesia bond market in August recorded negative performance. The volatility in the UST yields were driven by hawkish Fed statement and declining demand in the UST auction. Meanwhile Bank Indonesia held the interest rates constant for the seventh time in a row during its August meeting, in line with market expectations. Bl believed that the current levels were enough to keep inflation within the targeted range for both this year and the next year.
