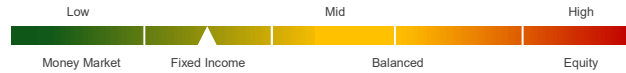

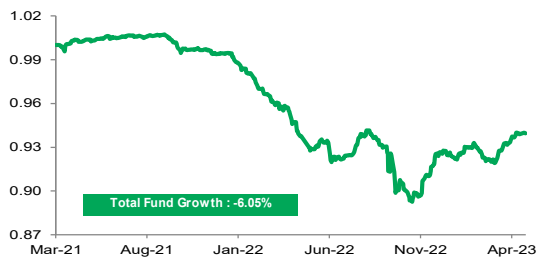

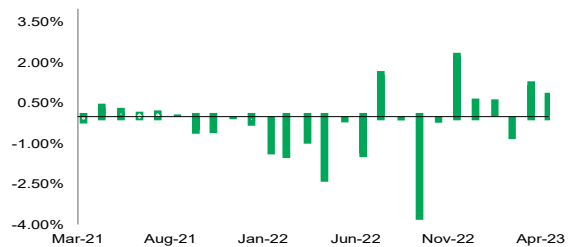

Monthly Performance Last 3 Years



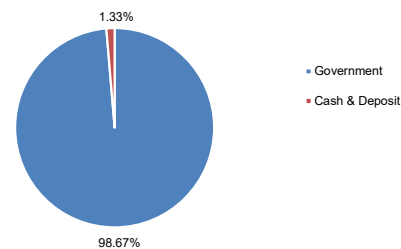

Investment Manager Commentary

Indonesia USD bond market strengthened in line with UST yield movement which lowered from 3.47% to 3.42% due to the heightened expectation of the possible last Fed rate hike in the upcoming FOMC Meeting in May. This expectation added positive fuel to the market bolstered its resilient performance. In line with The Fed's more dovish tendency stance, Bank Indonesia reaffirmed its monetary stance by holding its interest rate at 5.75%. Yields on short tenors fell more than medium tenors.
