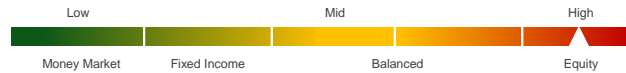

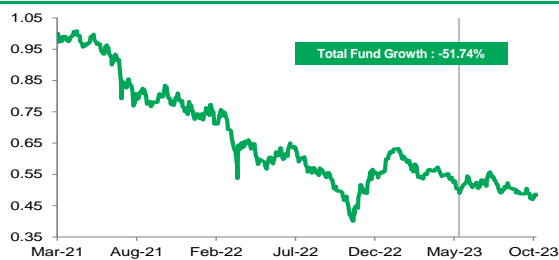

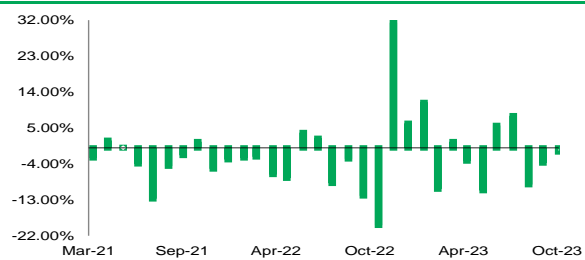

Monthly Performance Last 3 Years

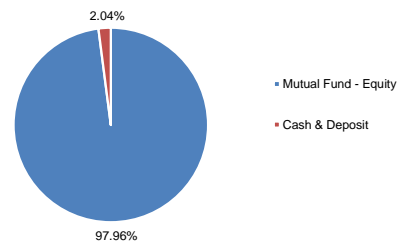

Investment Manager Commentary

China stock markets recorded negative performance, release of positive Chinese economic data and the government's latest steps to stimulate the sluggish economy have not been able to lift sentiment. President Xi stepped up his efforts to revive China's economy through a new debt issuance plan and an unprecedented visit to the central bank. This step boosts hopes for a recovery in consumption. Expectations on The Fed's "higher for longer" rate policy as inflation remains high while increased tension in the middle east triggered speculations on increased energy prices added pressure on equity market.
