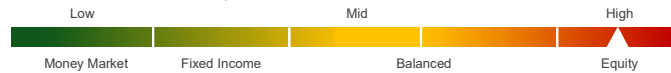

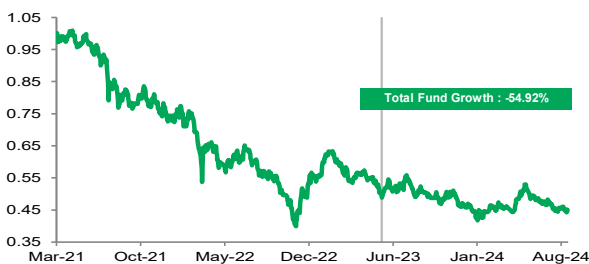

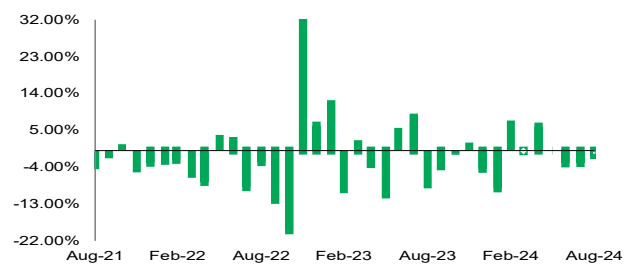

Monthly Performance Last 3 Years

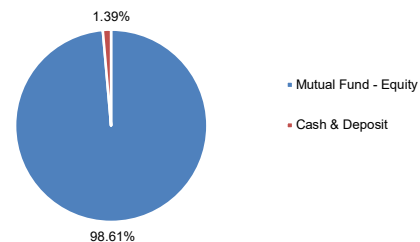

Investment Manager Commentary

Chinese equities were weak in August due to disappointing economic data. China's manufacturing, exports, and industrial data points to weaker outlook for the country. This raised concern to investors as the sectors were key to support China's economy, balancing the weaker domestic sector. Industrial production softened to 5.1% YoY in July from 5.3%, led by construction-related sectors. While July exports slowed to 7.0% YoY from 8.6%, amid concerns of easing global manufacturing activities. Overall appetite towards China remain weak in the month, as shown by downgrade of China's growth forecast from various global financial companies.
