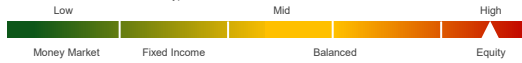

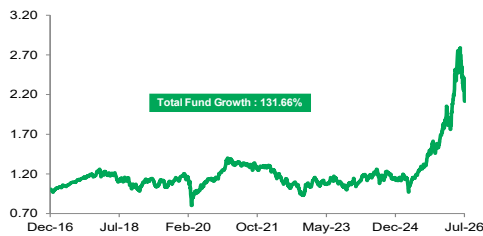

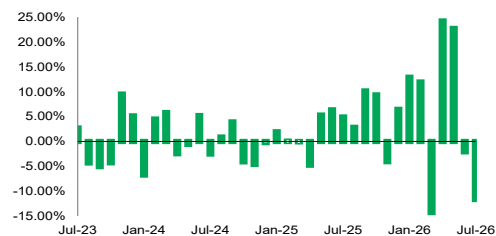

Monthly Performance Last 3 Years

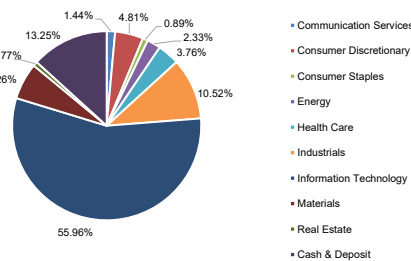

Investment Manager Commentary

Asia Pacific ex Japan equities were volatile in July amid renewed geopolitical tensions stemming from the escalating US-Iran conflict and volatility in the technology sector. Weakness in South Korea and Taiwan outweighed strength in China and Australia. Brent crude oil prices moved higher as the conflict disrupted key shipping routes through the Strait of Hormuz and the Bab el-Mandeb Strait. Meanwhile, The Fed kept its policy rate unchanged at 3.50%-3.75%, in line with market expectations. However, the FOMC consensus turned more hawkish, with three policymakers voting in favor of a rate hike. Technology-heavy markets such as South Korea and Taiwan were pressured by the sharp pullback in AI-related semiconductors and memory names, while China and Australia offered pockets of relative strength. China market posted positive performance despite sharp weakness across portions of China's technology sector, with policy support measures and strength in other parts of the market helping offset those declines. While performance in Australia was supported by stronger-than-expected employment data, improving business activity, and leadership from energy and financial stocks. Portfolio allocations in IT contributed positive attributions, meanwhile allocations in consumer discretionary contributed negative attributions to performance.
