Manulife Indonesia Pays Rp 8.1 trillion in claims in 2022, demonstrating its customer commitment

JAKARTA – Manulife Indonesia paid out total claims of Rp 8.1* trillion in 2022, helping to provide valuable support and peace of mind to local families at important times in their lives.

The overall payout equates to Rp 22.1 billion per day, or Rp 900 million an hour, demonstrating Manulife Indonesia's commitment to its customers. The announcement came in Manulife Indonesia's annual financial statements, which also showed that net insurance premium income was Rp 10 trillion in 2022, while total revenue was Rp 12.6 trillion. Manulife Indonesia's Rp 60 trillion of total assets was the second largest among life insurance companies in the country. **

"We recorded a solid business performance in 2022 that enabled us to help over around 2 million customers and their families in protecting their future. Our claims payout demonstrates our strong commitment to customers, and we also launched several solutions of life and endowment insurance protection to enable our customers to make their lives better and decisions easier," said Ryan Charland, President, Director & CEO of Manulife Indonesia.

Manulife Indonesia showed its strong financial platform, by recording its capital position far exceeding the government regulation of 120% with Risk-Based Capital (RBC) of 587% in conventional business and 664% Tabarru's Sharia in Sharia Units. Manulife's policy reserves stood at Rp 41 trillion, which asserts Manulife's commitment to ensuring long-term financial protection for all its customers in Indonesia.

Also, during 2022, Manulife Aset Manajemen Indonesia (MAMI) retained its position as Indonesia's largest investment management company.

Afifa, CEO & President Director of MAMI, said, "We have a strong commitment to providing easy access for the general public to our mutual fund products, and of course, providing the best investment solutions for all individual and institutional investors. Implementing this commitment has enabled MAMI to maintain its position as the largest investment manager in Indonesia*** despite the challenging dynamics and conditions of the capital market," she added. "At the end of 2022, our mutual fund assets under management (AUM) amounted to IDR 45.7 trillion. This achievement is due to the trust of all investors and the support of MAMI's 34 mutual fund distribution partners".
